SUMMARY ANNUAL REPORT

FOR MEDICAL EXPENSE REIMBURSMENT PLAN OF THE SOUTHERN CALIFORNIA PUBLIC SAFETY RETIREE MEDICAL TRUST

This is a summary of the annual report of the Medical Expense Reimbursement Plan of the Southern California Public Safety Retiree Medical Trust, E.I.N. 95-6047240, Plan No. 501, for the year ended January 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$7,673,857 as of January 31, 2022, compared to \$6,800,608 as of February 1, 2021. During the plan year, the plan experienced an increase in its net assets of \$873,249. During the plan year, the plan had total income of \$1,263,680 including employer contributions of \$423,120, and income from investments of \$840,560.

Plan expenses were \$390,431. These expenses included \$110,644 in administrative expenses and \$279,787 in benefits paid to participants.
